1 Introduction

2.2 Allocation of funding

As reported in SDRC report 9.5.1, a minimum of seven clusters with 10 or more participants were established and consequently, the project has committed the full allocation of funding for implementation of the trials.

The work associated with this predominantly covers:

- Provision of all vehicle subsidies.
- Purchase of all equipment.
- Installation costs.
- Maintenance cost, including updates to control settings throughout the project.
- Decommissioning costs.
